### What does the fund invest in?

The fund invests primarily in Canadian fixed income, investment trust units and equity investments to seek to achieve its investment objective, which is to provide a consistent stream of monthly income and some capital appreciation. Up to 30% of the portfolio may be invested in foreign issuers. The charts below give you a snapshot of the fund's investments on March 31, 2018. The fund's investments will change.

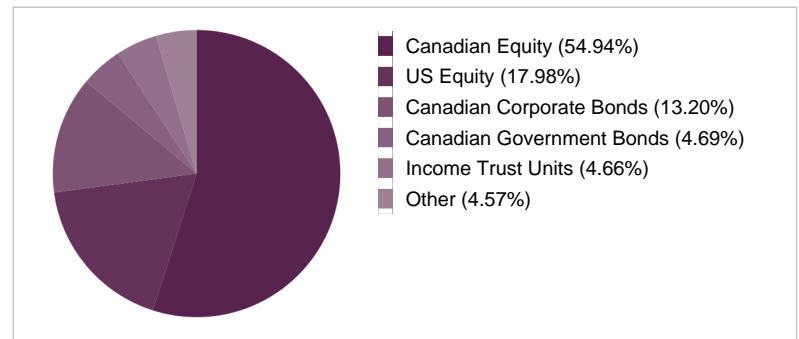

### How risky is it?

The value of the fund can go down as well as up. You could lose money.

One way to gauge risk is to look at how much a fund's returns change over time. This is called "volatility".

In general, funds with higher volatility will have returns that change more over time. They typically have a greater chance of losing money and may have a greater chance of higher returns. Funds with lower volatility tend to have returns that change less over time. They typically have lower returns and may have a lower chance of losing money.

### Risk rating

FAM has rated the volatility of this fund as **low to medium**.

This rating is based on how much the fund's returns have changed from year to year. It doesn't tell you how volatile the fund will be in the future. The rating can change over time. A fund with a low risk rating can still lose money.

## Who is the fund for?

### Investors who:

- are seeking a steady flow of income and modest capital growth
- are looking for a medium to long term investment
- are comfortable with moderate changes in value during the term

 Don't buy this fund if you have a low tolerance for risk and are seeking to preserve capital.

## A word about tax

In general, you'll have to pay income tax on any money you make on a fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account.

Keep in mind that if you hold your fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.

## How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Class A5 units of the fund.

The fees and expenses – including any commissions – can vary among classes of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about the funds and investments that may be suitable for you at a lower cost.

### 1. Sales charges

You have to choose a sales charge option when you buy the fund. Ask about the pros and cons of each option.

## How much does it cost? (cont'd)

### 2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund's returns.

As of December 31, 2017, the fund's expenses were 2.36% of its value. This equals \$23.60 for every \$1,000 invested.

### More about the trailing commission

The trailing commission is an ongoing commission. FAM pays your representative's firm a trailing commission for as long as you own units of the fund. It is for the services and advice your representative and their firm provide to you. Your representative's firm may pay part of the trailing commission to their representatives.

The trailing commission is paid out of the management fee and is based on the value of your investment. The rate depends on the sales charge option you choose:

Sales charge option	Amount of trailing commission

<b>Initial sales charge</b>	1.00% of the value of your investment each year	\$10.00 each year on every \$1,000 invested
<b>Deferred sales charge</b>	0.50% of the value of your investment each year	\$5.00 each year on every \$1,000 invested
<b>Low load sales charge</b>	1.00% of the value of your investment each year	\$10.00 each year on every \$1,000 invested

### 3. Other fees

You may have to pay other fees when you buy, hold, sell or switch units of the fund.

Fee	What you pay
<b>Short-term trading fee</b>	2% of the value of units you sell or switch within 90 days of buying them. This fee goes to the fund.
<b>Switch fee</b>	Your representative's firm may charge you up to 2% of the value of units you switch to another imaxxFund.

## What if I change my mind?

Under securities law in some provinces and territories, you have the right to:

- withdraw from an agreement to buy mutual fund within two business days after you receive a simplified prospectus or Fund Facts document, or
- cancel your purchase within 48 hours after you receive confirmation of the purchase.

In some provinces and territories, you also have the right to cancel a purchase, or in some jurisdictions, claim damages, if the simplified prospectus, annual information form, Fund Facts document or financial statements contain a misrepresentation. You must act within the time limit set by the securities law in your province or territory.
